2013 - REAA's Year Two

1 November 2013 marked the end of our Association's second year of existence. 'Low key' best describes the activity of our second year as we let the system we put in place during our first year play out to determine where the 'forgots' and 'fine-tuning requirements' might be. All-in-all, our first year's efforts caught most things so this year's report will be much briefer than last year's.

Board Composition. Board Members are elected for a four-year term; however, in order to stagger the terms for continuity, the first election (2011) had three two-year positions - Ike Crawley, Jim 'Bluto' Keys and Phil Young were elected to those positions - and they expire on 1 Jan 14. During the summer, we initiated action to fill the upcoming vacancies by soliciting you all for nominations. We received a grand total of three inputs: Ike, Bluto, and Neena Wright. Surprisingly, after painstakingly counting all 17 votes, they were all unanimously elected! Thanks to all three for stepping up - and thanks to Phil for your two years' service as Vice Pres and store manager.

Board composition for the next two years will now consist of the three permanent members - Bob Breault (coeditor and comms), Ben Galloway (coeditor and comms) and John 'Admiral' Nelson (Treas); the six elected members - Ike Crawley, Jim Keys (Vice Pres), Larry Mason (Sec'y), Mike Scott (Pres), Neena Wright and Rob Zettel. Additionally, Earl Henderson and Gail Peck were president picks' as ex-officio/ emeritus members – they don't vote but they do partake in our discussions.

Finances. At year's end, the association's treasury will show over \$9000 on hand. These funds have primarily been generated by dues subscriptions. However, our store is now generating positive cash flow as sales have covered the inventory costs and, except for mailing costs, all current income is going directly to the treasury. Currently, our monies have two main purposes: they fund ongoing expenses such as corporate license renewal, tax prep, website, etc; and, they will be used to offset reunion expenses and, also, in some manner, assist active dues-payers with their reunion expenses.

Store Information. One of the issues that the Board felt needed refinement was the management of our store. When considering the customer ordering procedure, funds handling requirements, product mailing, advertising, inventory management, etc, it was felt that we needed two important changes – consolidation of involvement, and an assurance of continuity should something happen to the manager (we are old!). Correspondingly, as of 1 Jan '14, Ben Galloway will assume store duties. Ben is a permanent Board Member, he and Melody developed
